THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 207(4), first subparagraph, in conjunction with Article 218(6), second subparagraph, point (a)(v), thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament<sup>1</sup>,

The President of the Council shall, on behalf of the Union, give the notification provided for in Article 23.2 of the Agreement between the European Union and Japan for an Economic Partnership, in order to express the consent of the Union to be bound by the Protocol<sup>6</sup>.

This Decision shall enter into force on the date of its adoption.
